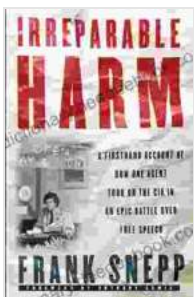


Firsthand Account: An Agent's Epic Battle Against the CIA Over Free Speech

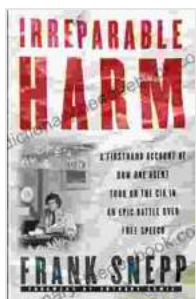
